#### Privacy declaration

#### 1 Introduction

We take your privacy very seriously. This page explains what information we collect about you, how we can use this information and what steps we take to ensure it is kept secure while using El Colibri.

By using El Colibri or by visiting any part of this website, you agree to the collection and use of information in accordance with this Privacy Policy and you are deemed to have fully agreed to this Privacy Policy. By submitting your personal information to us, you will be treated as a person who has consented to the disclosures referenced in this policy. The webshop cannot be used if one would not agree with these general terms and conditions.

International users - By visiting our website and providing us with your information, you acknowledge and agree that due to the international dimension of the site, we may use the information collected during our relationship for the purposes set out in this policy or in our other communications with you, including transfers of information outside of your own jurisdiction. In addition, you should understand that such data may be stored on servers located outside the jurisdiction of your country. By providing us with your information, you consent to the transfer of such information.

## 2. Information We May Collect

## 2.1 Personally Identifiable Information (PII)

By using El Colibri, we may ask you to provide us with certain Personally Identifiable Information that can be used to contact or identify you. This includes, but is not limited to, your name, email address, telephone number and postal address. This information is used to process your orders when you purchase goods or services from us.

We do not use or disclose your collected personal information for any purpose other than its primary purpose without first obtaining your consent or when required by law.

# 2.2 Device information

When you visit El Colibri, our internet service provider makes a note of your visit. The computer systems and software used by the site acquire certain personal data in the normal course of the service, which is necessary in order to use the Internet communication protocols.

Also, the following information is recorded, used and monitored for statistical purposes, privacy policy enforcement and to facilitate user disputes:

- IP addresses and other technical information
- Date and time of your visit
- Page views and website interaction

This data will be canceled immediately after processing and will only be used for anonymous statistical data related to the use of the site and to check that it is working correctly. The data can also be used to investigate responsibility in case of computer crime damaging the site; apart from this option, the data relating to web contacts will not be stored for more than thirty days.

#### 2.3 Cookies

We use cookies to store data while you visit El Colibrishop. You can configure your browser to refuse our cookies. However, this can lead to disruption of our service, such as not being able to log in and not saving products in your shopping cart. If you want to delete our cookies, we recommend installing a plug-in that will delete cookies after your visit.

These are the types of cookies we store on your device:

We may disclose the information collected above, if required by law or in the good faith belief that such disclosure is reasonably necessary to respond to subpoenas, court orders or other legal process.

We may also disclose the above information collected to law enforcement or others, in the good faith belief that such disclosure is reasonably necessary to: enforce our Privacy Policy; Respond to claims that posting a message or other content violates the rights of third parties; or to protect our rights.

## 3. Data encryption and storage

El Colibrishop uses SSL encryption technology. Your communication with us will only be transferred as encrypted data. We use computer safeguards such as firewalls and data encryption, we require physical access controls to our buildings and files, and we authorize access to personal information only for those employees who need it to fulfill their job responsibilities.

We primarily store and process your personal data in the EU / European Economic Area ("EEA"). If we transfer your personal information outside of the EEA, it is because you have consented to it or we have a legal reason to do so.

We do not keep your personal information longer than required.

# 4. Service Providers

We may share your personal information with third parties to facilitate our service. These services include, but are not limited to:

- Payment service providers
- Delivery services
- Administration and billing services

Our agreements stipulate that these service providers will only use your information in connection with the services they perform for us and not for their own benefit.

#### 5. Protection of children
